In continuation to the Ministry's letter of even No. dated 01.03.2016 wherein a Letter of Intent was issued to the Trust to establish a new Ayurvedic college with 100 seats in UG (BAMS) course with respect to the proposal submitted to the Central Government as cited above, I am directed to say that after careful consideration of the recommendations & report of the CCIM in terms of criteria as specified in the Regulations 3 and 10 of the Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations of 2013, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC), Ministry of AYUSH for the UG/PG course(s); permission of the Central Government is hereby accorded to the Secretary, S.G.C. Welfare Trust, Village- Kudana Chak, Near Brijghat, District-Amroha, Pin-244235, Uttar Pradesh to establish a new Ayurveda College in the name of "Sanjeevani Ayurvedic Medical College, Village- Kudana Chak, Near Brijghat, District-Amroha, Uttar Pradesh" with intake capacity of 100 seats in BAMS course from the academic session 2016-17 under the provisions of the section 13A of the IMCC Act, 1970. - (ii) Relevant provisions of the Minimum Standards Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 and Regulation 10 of the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospital) Regulations, 2012 read with amendment Regulations of 2013 by 31st December 2016, to get conditional permission for the session 2017-18;

- (iii) Relevant requirements under the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) (Amendment) Regulations, 2012 read with amendment Regulations of 2013 (for UG Ayurveda).
- 2. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the relevant CCIM Regulations, are in position before the admission of the first batch of students in the 1st professional of BAMS course is made, under intimation to the Central Government and CCIM.
- 3. The college has to develop the requisite infrastructure for IInd, IIIrd and IVth professionals well in time as per the CCIM norms which will be verified and reported by the CCIM at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
- 4. The college administration may take up the matter for recognition of the qualification under section 14(2) of the IMCC Act, 1970 at that time when the first batch of students admitted against this course appears for the final professional examination of the said course.
